I am directed to convey the approval of this Ministry for authorization of the following **Testing Centre** to test the **Post Harvesting Technology Equipments and Machinery**.

"Farm Machinery Testing Center, ICAR-Central Institute of Agricultural Engineering-Regional Center, Sugarcane Breeding Institute Post, Veerakeralam Road, Coimbatore-641007 (Tamil Nadu)"

The approval is subject to following Terms & Conditions:

- (i) The Test Centre will be authorized to test the Post Harvesting Technology Equipments & Machineries. The testing authority of test centre has to ensure before admitting any test sample for the readiness of the testing facilities at their test Centre.
- (ii) Testing regulations and procedure should be complied fully and followed scrupulously. The testing charges will also be applicable as per SMAM Guidelines only.
- (iii) Test centers would offer their services directly to the manufacturer only.
- (iv) Each report would be signed by HOD, and two Testing Engineers involved in Testing.
- (v) The testing authority at SRFMTTI, Anatapur, will monitor and review the ongoing testing activities once in a year and shall provide the necessary technical assistance in implementation of test procedures, documentation as per guidelines of SMAM.
- (vi) Copy of the Test Report of tested machines shall be sent to all FMTTIs and this Department.
- (vii) Faculties/Officers at the level of monitoring, Supervision and execution of day to day Testing activities must be from the relevant field.
- (viii) Testing Authority will take application and specifications/drawings as per the prescribed format from the manufacturer only.
- (ix) Testing Authority will ensure 2-3 weeks Training of their regular/testing staff responsible for execution of testing activities at ground leve at CIAE Bhopal or CIPHET Ludhiana.
- (x) In house facility shall be developed for calibration of their measuring/testing instruments or outsourced from an authorized/ Government agency.
- (xi) The outsourcing of the "Chemical Testing" of any critical component would be carried out from any NABL/BIS accridited Labs only.
- (xii) A proper record, log books and documentation of tested machinery would be maintained to ensure the transparency.

- (xiii) Periodical progress report (monthly, quarterly and yearly) will be forwarded to this Ministry and SRFMTTI, Anatapur and same will be uploaded on the web-site of the Regional Center of CIAE Bhopal at Coimbatore
- (xiv) For any Change in location/Shifting of Test centre in future, prior permission of the DAC&FW, Ministry of Agriculture & Farmers welfare is essentially required.
- (xv) The testing centre may be inspected by any concerned authority of this Division without any prior notice at any time.
- (xvi) The **Director, CIAE Bhopal**, shall depute a senior Level Scientist to do the annual inspection/audit of the Test Centre.
- (xvii) The DAC&FW reserves the right to withdraw the authorization without assigning any reason.
